SUBJECT PROGRESS REPORT ON ACTIVITIES – CORE AREA WASTEWATER TREATMENT

PURPOSE

To provide a progress report on activities on the sewage treatment project to the Core Area Liquid Waste Management Committee (CALWMC).

Past Activities

- planning funding agreement approved
- completed second peer review workshop on 22-23 March
- met with Ministry of Environment staff and consulting team to review Environmental Impact Study requirements
- prepared public education advertisements
- prepared public consultation presentation material
- reported on inflow and infiltration (I&I)
- reviewed the Sustainability Assessment Framework (SAF) analysis for each option
- attended UVic workshop on Opportunities for Integrated Energy Management
- met with the Greater Victoria Harbour Authority (GVHA)
- prepared options for cost allocation

Current Activities

- Request for Qualifications (RFQ) issued to select program manager consultant
- environmental and social reviews are underway for sites in Saanich east
- establishing planning funding agreement claims process
- wastewater characterization program is underway
- peer review team preparing report to answer CALWMC questions
- preparing allocation of system costs and revenue methods
- preparing a report on alternative service delivery
- developing a memorandum of understanding with key stakeholders interested either in using recovered resources or in working together on wastewater priorities
- memorandum of understanding with Esquimalt First Nation is undergoing final review
- sessions with all three First Nations underway to gain information and advice on project
- seeking partnerships with memorandums of understanding
- refining SAF
- attending open houses and compiling questionnaire responses
- preparing for community dialogue workshops
- determining if Canadian Environmental Assessment Act requirements will apply to our project
- visited southeast False Creek District heating system in Vancouver

- report on Liquid Waste Management Plan amendments
- I&I bi-annual report to MOE
- peer review workshop #3 in April
- provide presentation to GVHA Board
