- 6. Staff Reports
  - a) Staff News

#### Mount Matheson Statutory Right of Way

R. Hamilton spoke to mapping outlining the statutory-right-of-way (SRW) registered on May 17. The SRW will run from the cul-de-sac at the top of Matheson Lake Road to the boundary of Matheson Lake Regional Park. By previous agreement, JdFEA Community Parks will be responsible (with funding organized through the Mount Matheson Conservation Society) for building a trail within the SRW and Regional Parks will be responsible for building the trail from the park boundary to connect to existing trails.

Due to steep terrain, the trail standard will be primitive. Commission comment was forwarded suggesting that the Mount Matheson Conservation Society may be interested in a stewardship agreement.

#### Port Renfrew Recreation Centre – Library Contract

R. Hamilton presented pictures showing the interior components of the work started on May 17. Renovation work will be completed by June. A five year lease agreement with the Vancouver Island Regional Library (VIRL) will commence July 1.

R. Hamilton responded to Commission comment advising that he will ask VIRL if they need book donations for this location.

#### Seagirt Ponds Preservation Society Stewardship Agreement

R. Hamilton advised that the Stewardship Agreement with the Seagirt Ponds Preservation Society has been signed by all parties. The Society held its first membership meeting on Monday, May 13, which Commission Chair Louise Paterson attended. The Society does not plan to do any work on the park until this fall, and will focus on removal of invasive species. To date, no CRD volunteer application forms have been submitted.

#### Fishboat Bay Information Kiosk

R. Hamilton presented pictures of the new kiosk installed at the trail head of the park. Additional no camping and no fire signs will be posted in the beach area.

#### Carpenter Road Park Stairs and Bench

Pictures were presented of the stairs and bench pad locations. Installation of the stairs and viewpoint bench to be completed within the next two weeks.

#### Otter Point Park Memorial Bench

The plaque with wording was presented. It was advised that the work crew will arrange a site visit with the donor once installation is complete.

## Wrigglesworth Caretaker

The caretaking services at Wrigglesworth Park Reserve have commenced and will continue through to mid-October. The caretaker has already curtailed attempts to take down signs and get through the park gate. As the caretaker is receiving a benefit (camping without paying a fee), the caretaker has agreed to pay \$100 per month in order to qualify for a volunteer agreement and CRD insurance coverage.
