EP – Electronic Participation

The meeting was called to order at 3:01 pm.

1. Territorial Acknowledgement

The Chair provided a Territorial Acknowledgement.

2. Approval of the Agenda

MOVED by Commissioner Sloan, SECONDED by Commissioner McAndrews that the agenda be approved.

3. Adoption of Minutes from the Meeting of April 23, 2024

MOVED by Commissioner Guenard, **SECONDED** by Director Wickheim that the minutes from the meeting of April 23, 2024, be adopted.

4. Chair's Report

The Chair welcomed everyone to the meeting.

5. Director's Report

The Director forwarded positive comment on the improvements being made by local volunteers at Butler Park and on the maintenance being done at Elrose Park.

It was advised that there have been recent acts of vandalism in the CRD park system. It was asked that acts of park vandalism be reported to staff.

It was further advised that staff will be reporting on a complaint received regarding Mt. Matheson Community Trail.

6. Commissioner Reports

East Sooke – Seagirt Ponds

 the Seagirt Ponds Preservation Society has been provided with an archaeological site inventory map which identifies areas of no disturbance which will support the Society in its endeavours to remove invasive species

East Sooke – Copper Mine

- the tennis/pickle ball court and playground continue to receive high use

Don Closson confirmed staff will be replacing the pickleball court net.

Otter Point – Admiral's Forest

- a work party is being arranged by the Juan de Fuca Community Trails Society

Port Renfrew – The Park

- comment was received from the public supporting speed mitigation measures due to increased visitor traffic
- the Canadian flag requires replacement

Don Closson confirmed that the flag will be replaced prior to Canada Day celebrations.

7. Staff Reports

a) Staff News

Don Closson provided an overview of the report. Additional information points were provided on the following items:

Priest Cabin

The Chair stated support for directional arrows on a segment of the trail. Location to be shared with staff after the meeting.

Butler Road Park Improvements

- the Environmental Assessment Report will address riparian considerations as the park is adjacent to a pond and watercourse and will provide guidance on future park improvements
- the local volunteer group has taken the initiative to use the park to provide education on native plants with local schools and Scouts Canada
- volunteer group working with TreeCanada (not-for-profit funding agency) on providing vegetation for planting at a public information session and work party on September 21, 2024

Lot 64 – Port Renfrew

The Chair stated support for additional handrails on a steep portion of the stairway trail. A rope railing was suggested.

Mount Matheson Connector Trail

- a Community Works Fund application is under consideration to support installation of fencing on each side of a segment of the trail to address reports of user/pet trespass
- total project cost is \$20,000 with each adjacent property owner being required to contribute \$5000
- agreement from the property owners has yet to be received

The Chair stated support for the proposed fencing project, should the property owners agree to cost-sharing.

Active Transportation Network Plan

- kick-off meeting with the consultant and senior staff scheduled for June 26.

8. New Business

a) Capital Plan Amendment – Community Works Fund – Port Renfrew Community Centre Condition Assessment and Repairs

As initially reported at the March 26, 2024, meeting, Don Closson advised that a Community Works Fund application has been submitted to commence with a condition assessment for the Port Renfrew Community Centre. Funding of \$75,000 has been requested to support the assessment and anticipated recommended repairs.

Commission discussion ensued regarding requesting funding for repairs prior to review of the condition assessment and potential delays, should two funding applications be pursued.

MOVED by Commissioner Guenard, **SECONDED** by Commissioner McAndrews that the Juan de Fuca Electoral Area Parks and Recreation Advisory recommends that the Capital Plan for 2024 be amended to support a Community Works Fund to authorize \$75,000 to support a condition assessment for the Port Renfrew Community Centre and immediate repairs.

STAFF REPORT TO THE JUAN DE FUCA ELECTORAL AREA PARKS AND RECREATION ADVISORY COMMISSION MEETING OF TUESDAY, OCTOBER 22, 2024

SUBJECT: Staff News

ISSUE: Information

Priest Cabin

- The Manager with help from CRD Real Estate renewed the access agreement at Priest Cabin Park for one year.
 - Maintenance work scheduled for June 2024 has been completed. Additional split rail is planned to help identify trail access locations.
- The bench at Priest Cabin (lookout location) has been given a coat of stain.

Kemp Lake Fishing Dock – Chubb Road Location

Work underway and to be done to relocate dock facility at the Chubb Road location:

- Removal of old dock, scheduled for July 02 has been completed.
- Dock installation, scheduled for July 09 11 has been completed.
- Monitoring for "Western Painted Turtle" presence started June 01 and continued until dock installation was completed. No sightings were reported or observed.
- Picnic table and bear proof garbage bin have be installed.
- Additional split rail fencing has been installed to protect the picnic table.

Butler Road Park Improvements

Improvements have been discussed and underway:

- Reforestation and/or revegetation ongoing.
- Review of Environmental Assessment Report requirements began spring 2024. The Manager is reviewing the draft report.
- Cedar split rail fencing has been installed to show access options and beautify the area.
- Rock and gravel have been situated in the park to allow for fire breaks and definition of the planted areas.
- The volunteer group has connected with TreeCanada, a not-for-profit organization that will provide funding for vegetation planned for the site. A public event was held September 28 to continue planting efforts and site renewal. This event is supported by a contribution of \$5,000 from TreeCanada.
- Large boulders and tree-stumps have been solicited for the site, proper placement has yet to be completed.
- A "Willow Tunnel" is proposed for the site, the volunteer group is having difficulty finding adequate material (Scouler's willow) at this time to complete this feature.
- The information kiosk (sign) has been completed; it may require a coat of stain.

The Park – Port Renfrew

Several concerns were raised by Pacheedaht and local residents regarding the existing equipment and proposed replacement playground during the open house. The open house was well-attended, and several possible improvements were suggested:

- repair the zip-line track ride as soon as possible underway
- continue with general maintenance items such as greasing the equipment, garbage removal and hazard abatement underway

With the assistance of the CRD Archaeology Manager, archaeological work has commenced at The Park. Initial work will consist of background information gathering and local resident interviews, followed physical ground truthing work. The draft report is scheduled to be completed by November 30, 2024.

Lot 64 – Port Renfrew

Trail and Parking Lot construction project planned works include:

- A trail that connects the tennis court to the marina trail.
- Define the boundaries of Lot 64 with possible fencing.
- Removal of debris. A burn pile was removed in April with the assistance of the CRD contaminated sites program.
- Define the parking lot area at the tennis court.

The initial work will consist of background information gathering and local resident interviews for Lot 64.

This trail project is on hold due to the concerns raised at the open house.

Fishboat Bay

A Community Works Fund (CWF) application has been applied for to complete staircase and viewing platform.

A list of project considerations is being complied to assist in charting a course forward for this project.

- The CRD Archeologist has been contacted to start an archaeological survey for the site.
- A geotechnical contractor has been consulted to start work on a steep slope survey as required under the development permit.
- A request for an updated License of Occupation has been submitted to the Ministry of Transportation and Infrastructure (MoTI).
- The Manager has contacted a consultant to request a rendering/drawing of the planned viewing platform.

Admiral's Forest

Work at Admiral's Forest continues with the installation of split rail fencing/signage to define park boundaries and closed trails. Split rail fencing will be used to improve main access trail locations (ongoing).

The Manager has purchased coloured discs corresponding to the colour scheme associated with the various trails. Staff will secure the coloured discs along the length of each trail to assist the public with location identification. The discs are currently being deployed at Admiral's Forest.

Copper Mine Park

The Manager is working with the Director to enhance parking along Copper Mine Road near the Canada Post mailboxes.

A permit has been received from the MoTI to allow improvements to be made.

Material (rock) for these planned improvements will come from the pumphouse replacement project planned for adjacent property at Copper Mine Park. Additional gravel may have to be obtained to provide a smooth-running surface.

Excess material was removed from the area on October 07 by a contractor.

The bear-proof garbage bin has been installed.

Seagirt Ponds Park

The Manager has determined that a large-scale treatment option for yellow flag iris is not necessary. A potential treatment window, which was originally scheduled for the first week of July has been deferred.

The Manager is working with a local resident on confirmation of memorial bench dedication. This effort has been put on hold at this time at the request of the person wishing to contribute the bench.

The bear-proof garbage bin has been installed.

Wieland Road Trail Project

Elements of the project:

- This will be a multi-year project.
- At its meeting of March 26, the Commission recommended acceptance of the landowner's offer to secure/construct the trail portion on the Wieland Road statutory right-of-way to meet provision of park land requirement for subdivision (SU000711 & SU000756).
- The Commission's recommendation was supported by the Juan de Fuca Land Use Committee on May 21 and by the CRD Board on June 12.
- This trail section will be between the Kemp Lake Road (treed) section and the riparian area behind the storage business at Sooke Business Park (approximately 805 meters).
- The Manager has determined the location of trail on the road right-of-way. The landowner has been briefed on trail construction procedures and construction has been completed and accepted by the Manager.
- The Manager met with a not-for-profit entity, TreeCanada, on June 05 to discuss the potential for revegetation grant support for this project. The application will be sponsored by the Juan de Fuca Community Trails Society, which will assist in getting the application approved as the applicant cannot be a government organization.
- Quotes to connect Kemp Lake Road to the newly constructed trail (approx. 150 m) have been received and construction will begin soon.
- The successful contractor was Sooke Backhoe Services at \$19,000.00.

Sheringham Point Trail

Operational maintenance continues at Sheringham Point Trail.

Staff have placed gravel in a series of potholes near the Lighthouse parking lot (lower).

Mount Matheson Connector Trail

The Manager is working with a resident who lives adjacent to the Mount Matheson connector trail to determine if fencing the connector trail is a realistic solution to trespass issues from the public and their pets. The JdFEA Parks operation budget does not have adequate funding to support the proposed fencing solution. The Manager, with Commission and Electoral Area Director support, may choose to apply for CWF support. The cost for the fencing project is approximately \$10,000, with the resident required to pay half.

The fence would be black chain link, four feet high and approximately 100 meters long.

The local resident is working with the Manager to try and find a workable solution to the concerns raised. It appears that only one side of the trail will be fenced.

Port Renfrew Community Centre

- A CWF application has been submitted to commence with a condition assessment for the Port Renfrew Community Centre. The CWF application includes a funding request for repairs that will likely be identified in the assessment.
- Parks staff have replaced the boards on the picnic table outside the Community Centre.

2025 Provisional Budget Review

The Commission's bylaw, Bylaw No. 3763, directs that the Commission recommend approval of its budgets annually.

The Community Parks and Community Recreation budgets are provided for review and recommendation under New Business.

COMMISSION:

Continuation Bylaw #3763 (May 2011), an advisory commission for Community Parks and Recreation in the Juan de Fuca Electoral Area. Original establishment Bylaw for this commission Dec 2004.

AUTHORITY:

Requires written approval of electoral area Director. Participating electoral areas must be designated by bylaw.
