- Requested the inclusion of two covenants on the title, 1) that removes the

CRD and Colwood liability and 2) a restrictive covenant that prevents any structure higher than the existing reservoir.

Staff responded to questions from the Commission and provided additional information as follows:

- The gravity pipes are municipally-owned.
- A review of the remediation work still needs to be completed.
- Other property disposition within the Service Area more recently was the Whisperwind Reservoir Sites, which reverted back to the adjacent property owners; other sites have been disposed of via public disposition.
- Financial implications related to the restoration of the property still need to be reviewed.

That the Juan de Fuca Water Distribution Commission directs staff to:

For the Townview reservoir and pump station site, proceed with an engineering assessment and any necessary site stabilization improvements coincident with the demolition of the existing structures, rezone the property to R1, realign the public path, grant City of Colwood a statutory right of way for sanitary sewer, and then undertake a public disposition of the property.

REPORT TO JUAN DE FUCA WATER DISTRIBUTION COMMISSION MEETING OF TUESDAY, JUNE 2, 2020

SUBJECT 2020 - 2021 Juan de Fuca Water Distribution Capital Plan Amendment

ISSUE SUMMARY

It is proposed to amend the 2020 – 2021 Capital Plan and Financial Plan to adjust the budget and schedules for the Goldstream Avenue and Walfred Road – Phase 2 Asbestos Cement (AC) Pipe Replacement projects.

BACKGROUND

The approved 2020 – 2024 Juan de Fuca Water Distribution Capital Plan includes approximately 30 projects, many of which were planned or were instream for the 2020 budget year. One of the projects, the Goldstream Avenue AC pipe replacement project, is a highly complex project due to the extensive planning required both with the City of Langford and the existing commercial and residential customers served along the route. This project has a \$5 million (M) budget and was originally scheduled to be started and completed in 2020. As a result of the impacts of COVID-19 and the logistical challenges created with stakeholder engagement, the Goldstream Avenue project design schedule has been delayed. It is now proposed to begin project design in the fall of 2020 and begin construction in the spring of 2021. This will change the budget expenditure on this project to \$0.2M in 2020 and \$4.8M in 2021.

Further, in order to utilize the capital project delivery capacity resulting from the proposed Goldstream Avenue project schedule adjustment, it is proposed to reschedule Phase 2 of the Walfred Road AC pipe replacement project in the City of Langford from 2021 to 2020. Phase 1 of the Walfred Road project is currently under construction, so all design and permits are in place to continue on with Phase 2 construction this year. Phase 2 of the Walfred Road project consists of approximately 900 metres of 300 mm diameter ductile iron pipe with a budget of \$1.2M.

<u>ALTERNATIVES</u>

Alternative 1

The Juan de Fuca Water Distribution Commission recommends to the Capital Regional District Board, that the 2020-2021 Juan de Fuca Water Distribution Service Financial Plan be amended as shown in Appendix A.

Alternative 2

That this report be referred back to staff for additional information.

IMPLICATIONS

Financial Implications

Capital reserves are funded by transfers from the operating budget. Both projects were to be funded from capital reserve in 2020 and 2021. There is no expected impact to the current approved water rates.

CONCLUSION

The \$5M Goldstream Avenue AC Pipe Replacement project is unable to be completed as planned in 2020. To take advantage of timing and available resources, an alternate AC pipe replacement project originally scheduled for construction in 2021, Walfred Road – Phase 2, is now proposed to begin in 2020. The Walfred Road – Phase 2 project is valued at \$1.2M and would require no additional funding in 2020 due to the adjusted schedule for Goldstream Avenue project.

RECOMMENDATION

The Juan de Fuca Water Distribution Commission recommends to the Capital Regional District Board, that the 2020-2021 Juan de Fuca Water Distribution Service Financial Plan be amended as shown in Appendix A.







FAQs

How are water restriction stages determined?

Several factors are considered when determining water use restriction stages, including,

- 1. Time of year and typical seasonal water demand trends;
- 2. Precipitation and temperature conditions and forecasts;
- 3. Storage levels and storage volumes of water reservoirs (Sooke Lake Reservoir and the Goldstream Reservoirs) and draw down rates;
- 4. Stream flows and inflows into Sooke Lake Reservoir;
- 5. Water usage, recent consumption and trends; and customer compliance with restriction;
- 6. Water supply system performance.

The Regional Water Supply Commission will consider the above factors in making a determination to implement stage 2 or 3 restrictions, under the Water Conservation Bylaw.

At any time of the year and regardless of the water use restriction storage, customers are encouraged to limit discretionary water use in order to maximize the amount of water in the Regional Water Supply System Reservoirs available for nondiscretionary potable water use.

Stage 1 is normally initiated every year from May 1 to September 30 to manage outdoor use during the summer months. During this time, lawn watering is permitted twice a week at different times for even and odd numbered addresses.

Stage 2 Is initiated when it is determined that there is an acute water supply shortage. During this time, lawn water is permitted once a week at different times for even and odd numbered addresses.


Stage 3 Is initiated when it is determined that there is a severe water supply shortage. During this time, lawn watering is not permitted. Other outdoor water use activities are restricted as well.

SUBJECT Juan de Fuca Water Rate Structure Review

BACKGROUND

Several large residential developments are occurring in the Juan de Fuca (JDF) Water Distribution Service Area. As with any large scale, multiphase development that is constructed over a period of years, large water (and other utility) infrastructure is typically installed in the initial phase of the development and this infrastructure requires operation and maintenance from the outset. The service incurs the operation and maintenance expense, but during the initial phases and the buildout period while homes are being constructed, the water sales revenue resulting from consumption does not completely offset the operations and maintenance costs. The variance between the revenue and expense in this situation is partly a result of the JDF Water rate structure which is entirely consumption based. With the objective of determining a water rate structure that assumes a 'cost/revenue neutral' outcome for existing customers and generates revenue through a fixed charge that would take affect at the time of meter installation.

The Juan de Fuca Water Distribution Commission directs staff to conduct a rate structure review that considers a rate structure with a fixed charge component, such as a meter charge, and a consumption based volumetric component for comparison with the current consumption-based volumetric rate, with a goal of capturing revenue from serviced properties which are not consuming water, in order to assist with funding the operations and maintenance expenses incurred by the entire service area, for serviced developments.

<u>SUBJECT</u> Amendment to the *Board Remuneration and Travel Expense Reimbursement Policy*

BACKGROUND

The Regional Water Supply Commissioners receive a \$100 stipend per meeting for their attendance at a Regional Water Supply Commission meeting. Capital Regional District (CRD) Directors and other sub-regional and local Commission/Committee members receive remuneration for their responsibilities.
