5) Presentations:

5a) EMBC Earthquake Consultation Update: S. Tanaka of EMBC provided an update of the earthquake preparedness consultation process (presentation attached). Community Sessions will be taking place to seek input from the Local Governments and First Nations. Other sector specific stakeholders (such as Universities, NGOs, and Professional Associations) will have separate opportunities to provide their feedback. 5b) Tsunami Notification Update: T. Moore provided an update on the EMBC and National Tsunami Warning Centre notification process. He recommended that members sign up to EC Alert Me as another tool for receiving notifications.

6) Old Business:

- **6a) Tsunami Communications Exercise:** T. Whiting provided an update on the CRD tsunami emergency communications procedure. It is expected it will be in place for June.
- **6b) BCERMS Update:** The Governance section of the document is complete and the Response, Mitigation, and recovery sections will be completed by the end of June. It is expected that a draft document will be circulated for wide feedback in September.
- **6c) REPAC:** The REPAC meeting took place May 1. It was noted that a few working groups have completed their tasks and new working groups may need to form. A membership participation survey may be considered for the REPAC that is similar to one circulated by metro Vancouver's Regional Emergency Planning Committee.
- **6d) Regional Emergency Preparedness Workbook:** The workbook has been completed and is available on PrepareYourself.ca. S. Jansen will verify costs and arrange printing of the workbooks.
- **6e) Regional Telecommunications:** An update was provided, and the working group will meet prior to the next LG EPAC meeting.
- **6f) Mass Notification Systems:** An update was provided, and the working group will meet prior to the next LG EPAC meeting.
- 7) New Business: No new business to discuss.
- 8) Roundtable:
 - **7a) LG EPAC Meeting Location:** The June meeting will take place at the CRD and the July meeting will take place in Saanich.

EMBC will arrange for a presentation on a health emergency exercise taking place in September.
