# **LGEPAC Project Priorities**:

- 1. DMAA, Disaster Mutual Aid Agreement to support REMP project
- 2. Evacuation
- 3. HRVA, Regional Risk Assessment, CRTI, CBRNE to support REMP project
- 4. Public Education and Information, PSAs, Website, Prepare Yourself Workbook
- 5. REMP Liaison
- 6. REPAC Liaison, Guidance
- 7. Resource Coordination in Regional Response, Logistics, related to DMAA and Con-Ops

<u>Recommendations for REMP Project Priorities</u> (based on strategic plan, what should be focused on for the first year or so):

- 1. DMAA, Disaster Mutual Aid Agreement, with LGEPAC support
- 2. HRVA, Regional Risk Assessment, CRTI, CBRNE with LGEPAC support
- 3. Mitigation

## Who Does the Work?

### **Existing Model:**

With REMP, there is the potential for Working Groups at three levels:

- 1. REMP
- 2. LGEPAC
- 3. REPAC

# **Observed and Potential Issues with Exiting Model:**

- 1. **Silos** LGEPAC Working Groups tend to include government only. REPAC tend to include more non-government, industry and subject matter experts. Some issues demand contributions from all stakeholders.
- 2. **Inefficient** Duplication of effort, potential gaps in coverage. Some overlapping issues have caused confusion among participants, specifically which Working Group is doing what.
- 3. **Burn out** All Working Groups depend on volunteers, who have limited time. Poor support or access to resources could jeopardize objectives. Limited staff time.

# **Proposed Model:**

While each level may have internal work to do, the group proposed the Working Groups requiring multi-agency coordination to fall under REMP management.

- 1. REMP REMP would include Working Groups needed for big efforts that require staff support, contractor support, and funding, and/or political support. Membership of each Working Group will be determined by the objectives and affected stakeholders, and may include members of LGEPAC, REPAC, CAOs, federal government, First Nations, local universities, or anyone with expertise and representation. An LGEPAC representative and a Steering Committee representative will sit on each Working Group.
- LGEPAC LGEPAC Working Groups (it would be better to use the term "committees" to avoid confusion with REMP WGs) would continue efforts that concern only the local governments and do not require substantial external support or consultation. REPAC members may be included in some minor committee work.
- 3. REPAC These Working Groups will be disbanded, with volunteers advised to participate in the REMP Working Groups. REPAC will continue to meet four times a year, with at least two education/information sessions. REPAC participants will be offered opportunities for 1) Networking, 2) Receiving updates on regional initiatives, 3) Invitations to participate in REMP Working Groups.
- 4. **First Nations** Coordination of First Nations emergency management in the region is under development. It is potential for First Nations to organize a First Nations Emergency Program Advisory Commission, similar to LGEPAC. Regardless of ultimate organization, FN representatives will be specifically invited to participate in REMP Working Group issues of relevance within the region.

# **LGEPAC** Work Plan for upcoming months

- Continue active working group work, including:
  - Public Information working group

- Evacuation working group
- REMP working group
- o REPAC working group (revisit terms and processes)
- Assemble all local authority HRVA information
  - o In preparation for REMP to complete a regional HRVA
- Review and revise Disaster Mutual Aid Agreement
  - Include partners that are currently missing
  - o Pass over to REMP for endorsement and support
