- c) Realignment of Plumper Pass Loop Trail
 - The CRD sign plan was discussed with regards to the repetitive messaging about entering and leaving park boundaries.
 - Discussion occurred regarding the creation of a comprehensive map to include connecting and undocumented trails on Mayne Island.
 - The sign plan will be distributed for commissioners to consider the realignment of Plumper Pass Park Loop Trail.
 - Suggestions and concerns were raised, including that:
 - CRD note on their maps that hikes may travel through community parks.
 - Not having a comprehensive trail map will take away from the hiking and viewing experience and may cause hikers to become lost or confused.
 - o Having trails identified will support 911 emergency response calls to locate injured hikers.
 - This item will be brought forward for discussion at the next meeting.

Records Management

09 December, 2024

- 1. In the summer of 2023 members of the CRD Information Management department came to Mayne Island to provide information on upgrading and including the Mayne Island Parks and Recreation Commission in a SharePoint project within the CRD. The vision was to have a centralized document storage system that commissioners would be able to access and information could be easily shared.
- 2. All of MIPRC's documents stored in the Miners Bay library basement and many other documents stored offsite were taken back to CRD head office for storage and review.
- 3. The tentative date set for the initial trial system was the fall of 2023.
- 4. Since that time, CRD has been addressing a number of issues that have delayed the development of the SharePoint system and there is no tentative date set for when the system might be in operation. MIPRC has had several occasions in which they needed records or documents which were no longer accessible.
- 5. Given the uncertainty as to when a new system might be developed and the effect on MIPRC's operations, it is desirable to have the documents returned to MIPRC.

- 1. The Miners Bay men's and women's washroom painting is complete. The janitor is very pleased with the improvement and it has reduced frustration with not being able to clean the washrooms properly.
- 2. An additional gallon of paint needed to be purchased for the floors and was approved by Commissioner Bell.
- 3. Commissioner Wright has relocated the soap dispensers so they do not leak onto the floor and installed notice holders on the exterior doors to hold park notices.
- 4. A drip cup will be installed under the soap dispenser at Dinner Bay.
- A contract with a second septic pump out service is almost complete.

- 1. Torii gates,
 - a. Work continues on the inner torii gate.
 - i. Rot was found in one of the posts and is being removed with the wood being replaced and epoxied in.
 - b. The concrete work has been completed and will be open by Dec 16th.
 - c. The gates will not be reinstalled until the new year.
- 2. Arborist Matt Bolla completed the work in the JMG on Thursday 14th November. Wood chips from the removed trees/branches have been placed on the entry pathways.
