- discussed changes in CPR protocols to Continuous Compression model in lower mainland; Eileen & I will be investigating further
- suggested that we should consider buying a 4-gas monitor. Quote from Acklands Grainger distributed at meeting: ~\$3k for 1, a second & subsequent unit should cost ~\$1k more
 - 4-gas Monitor
 - to determine whether an Atmosphere is Immediately Dangerous to Life & Health
 - WCB? SGVFD? Sharing?
 - What is the schedule for the calibration gasses? Calibration off-site?
 - Propose to buy 2 monitors (1 for each hall to be carried on the engines), 2 cases & 1 set of calibration materials
 - Need fuller report to make a decision
