1. CALL TO ORDER

The meeting was called to order at 12:30 p.m.

2. APPROVAL OF THE AGENDA

3. ADOPTION OF THE MINUTES OF THE MEETING HELD 16 MARCH 2011

MOVED by Commissioner Derman and **SECONDED** by Commissioner Coleman, that the Regional Water Supply Commission adopt the minutes of the meeting held 16 March 2011 as distributed.

5. PRESENTATIONS/DELEGATIONS

6. WATER ADVISORY COMMITTEE (WAC)

Chair's Report

The Chair of the Water Advisory Committee reported on the following:

- The committee is currently discussing the difference in the water bills across the region, and will be
 recommending that there be a completely consistent water billing format system throughout all the
 municipalities which will generate a bill that is understandable;
- Work is underway on a review of the Strategic Plan for the Greater Victoria Water Supply System, with a public meeting to be held inviting comments on the draft plan.

<u>Billing Practices Across the Region</u> - The Commission asked the Water Advisory Committee to take a comprehensive look at billing practices around the region and the way that water is accounted for. The WAC could then prepare a report for the Commission's review that provides a comparison of which municipalities have a minimum charge and the volume of water allowed before a higher rate kicks in. Following receipt of this information, the Regional Water Supply Commission could then look at uniformity across the region. report on how they could provide information to municipalities that would support clarity to consumers

The Water Advisory Committee may also want to look at how other utilities provide information to their customers.

<u>Strategic Plan</u> – B. Wilkes reported that the draft plan will be provided to committee members at the end of May, followed by a discussion at the regular meeting in June. A public meeting will be scheduled following review and input by the Committee.

7. TRANSMISSION MAIN NO. 15, PAVEMENT RESTORATION PROJECT AT SOOKE POTHOLES – AWARD OF CONSTRUCTION CONTRACT

That the Regional Water Supply Commission award a construction contract to Capital City Paving Ltd. in the amount of \$233,889.60 (including HST) for the Transmission Main No. 15, Pavement Restoration Project at Sooke Potholes Regional Park.

- 2. Award the tender to purchase a new pickup truck to Jenner Chevrolet in the amount of \$35,809.75.
