## **SAFETY**

Program over budget – Current potential WWTP sites all result in significant additional costs.

## **SCHEDULE**

Procurement of WWTP DBF Contract delayed indefinitely.



- Uncertainty of site location has made the Program schedule unachievable. Additional delays anticipated.
- All activities suspended from June 27, 2014, with the exception of the construction of the Craigflower Pump Station and the design of the Arbutus Road attenuation tank.

## **RISK**



• The overall program completion of 2018 not possible as a result of the zoning impasse for the implementation of a wastewater treatment plant. 

#### 1. Executive Summary

#### 1.1 Seaterra Program

- 1.1.1 Costs this period are \$385,302 (See section 13.1.3 for details) for a total cost to date of \$40,828,228.
- 1.1.2 Commitments this period are negative \$8,813,885 for a total commitment to date of \$42,421,844 (approximately 5.4% of the Program budget).
- 1.1.3 Procurement activities on the Program remain suspended.
- 1.1.4 As a result of the suspension of procurement activities in June 2014, the Program schedule cannot be completed before the end of 2018. Acquisition of a new site and completion of any rezoning and environmental approvals required followed by the procurement, design, construction and commissioning of the wastewater treatment plant (WWTP) and the Resource Recovery Centre (RRC) are the activities that will determine and drive a revised Program critical path.
- 1.1.5 Construction related activities continued on the Craigflower Pump Station project. The pump station is effectively complete and the various systems are being tested and commissioned. The Pump Station is expected to be completed 12% under budget. The Seaterra Commission members toured the pump station on July 31, 2015.
- 1.1.6 The preferred proponent for the McLoughlin Wastewater Treatment Plant has extended the validity of their proposal to December 31, 2015 including the required \$2 million letters of credit.

#### Major Issues:

#### CRD:

- Approval of a WWTP site or sites.
- The LWMP approved by the MOE July 3, 2014 will require further amendment for changes to the Program resulting in a new site or multiple sites being identified in Q4, 2015 for the wastewater treatment plant and resource recovery centre.
- The Clover Pump Station rezoning application remains on hold pending further direction on the entire Seaterra Program.
- Relocation of rock/gravel stockpile from the proposed site of the RRC remains on hold.
- Environmental studies for a new WWTP site or sites.
- Site investigations for a new WWTP site or sites.
- Federal and Provincial environmental approvals and permits.
- Application and approval of Zoning for a new WWTP site or sites.
- Public consultation for a new WWTP site or sites.
- Liquid Waste Management Plan revisions and approval.
- Renegotiation of funding agreements.

Major Activities Planned – Next Period:

#### CRD:

 The CALWMC and CRD Board will meet in August 2015 to discuss next steps for the LWMP.

#### Commission/PMO:

 Awaiting direction from the CRD Board on an approved site or sites for the WWTP.

#### 5.1 Construction Status

5.1.1 The piping work is 100% complete and the pump station is effectively complete. The various systems are being tested and commissioned. Final inspections and deficiency lists are being completed. Seaterra Commission members toured the pump station on July 31, 2015.

- 5.2.1 The commissioning of the Pump Station has commenced. The pump station will be put into operation in August 2015.
