# 3) Report from Chair

- f) The rodent control removed 3 mice from the hall, trapping and outdoor baiting program continues, with servicing every 2 months.

a) Brian presented 3 quotes for cleaning and repainting the outside of the Hall and Annex, approximately \$15K - \$20K, Brian will estimate costs for the repairs to the siding so we can create a budget for the total project.

- b) Reminder it will be the 40<sup>th</sup> WPFD anniversary on Feb 20/2017.
- c) Vern has offered to fix the latch on the rear double doors of the Hall.
- d) Discussion regarding the flooding in the rear corner of crawl space, the rock pit is now not able to deal with the increased water flow from all buildings during a storm event; causing the perimeter drain to backup into the crawl space. Brent will dig an overflow drain from the rock pit to the rear bank to relieve overflow storm water.
