Who Is Eligible?

Residents of Central Saanich, North Saanich and Sidney, including Post Secondary students whose combined household gross income is within or below the Estimated Statistics Canada Low Income Thresholds as noted on the front of this application form.

How Do I Apply?

- 1. Bring identification such as Care Card, BC ID, Drivers License.
- 2. Bring current proof of residency for each adult applicant, such as a utility bill, rental agreement or government ID.
- 3. Bring previous year's Notice of Assessment (NOA) listing line 150 for each adult applicant as proof of combined gross annual household income. To obtain a copy of your NOA call Revenue Canada at 1-800-959-8281 or visit http://www.cra-arc.gc.ca/myaccount/
- 4. If you are a Refugee or arrived under the Canada-Ukraine Authorization for Emergency Travel in the last year. Bring your landing papers along with proof of residency. If you are staying with a host family, your proof of residency can be the host family's name.

Discount Options

Option A: Unlimited Drop-In and Program Subsidy (valid for a 2 yr period based on the activation date)

- Unlimited drop in visits to Panorama Recreation. Obtain a pass and swipe for every visit at Panorama.
- 52 Free Admissions to Drop-In Sessions at any Greater Victoria Recreation Centre (incl. West Shore, Saanich, City of Victoria, Oak Bay, Esquimalt and SEAPARC Recreation Centres). Note: to use these visits you MUST have the 52X sticker on your card and MUST present it at a regional facility or you will not gain admittance. You will require a new sticker for each calendar year. You will not receive unlimited visits at other regional centres.
- Subsidy amounts for the two year cycle will be \$150.00 per adults (19yrs and up) and \$250 per child/youth (0-18yrs)

Option B: Annual Regional Pass Discount – 50% OFF (valid one year from purchase)

- Receive this \$552 pass for \$276.00 (\$23/month, 12 month term)
- Unlimited access to drop-in programs at Panorama, West Shore, Saanich, City of Victoria, Oak Bay, Esquimalt and SEAPARC Recreation Centres

\$10.50 fee to replace a lost or stolen card.
