

## HARTLAND LANDFILL HOUSEHOLD HAZARDOUS WASTE PROGRAM

Household hazardous waste (HHW) under product stewardship is accepted in the public drop off area at Hartland Landfill from both residential and business generators. No pre-approval is required, there is no charge for this service and the CRD reserves the right to inspect and reject loads.

Non-stewardship HHW is only accepted from residential sources within the CRD. Residents transporting their own HHW to Hartland are not required to complete a declaration form but may be asked by landfill staff to provide information on the material they are depositing. If residents have a non-stewardship/program gas tank or fire extinguisher we will ask for some information to be written down.

Please ensure all HHW is transported upright and secure and not double stacked for safety purposes. If a container is leaking or of suspect integrity, please bag it and segregate it.

### **Conditions for acceptance of non-stewardship HHW from transporters other than residents:**

#### *Estate Clean-ups*

Relatives conducting an estate clean-up can transport HHW to Hartland Landfill themselves and are not required to complete a declaration form unless bringing non-stewardship/program gas tanks or fire extinguishers.

When transport of non-stewardship HHW material from an estate is conducted by a commercial waste hauler, a declaration form is required and should be completed by the estate's legal representative.

#### *Commercial Waste Haulers*

Commercial haulers transporting HHW from residential sources must complete a declaration form, have license to transport (LT) and manifest for waste amounts greater than as prescribed by the Hazardous Waste Regulation section 46 (1) Table 1 (please see page 2).

Loads should match the approved application and be from one generator only. Large quantity loads may be rejected. Large quantities are amounts higher than those normally stored by a resident. Haulers must inform the resident that there is no cost for disposal, only hauler charges.

#### *Non-profit Recycling Organizations*

Operators of registered non-profit recycling organizations are permitted to deposit HHW that has been received inadvertently through their operations. When completing the declaration form, the organization would be considered the generator.

Operators with non-stewardship HHW under the Transportation of Dangerous Goods (TDG) Regulation can transport waste below the threshold as indicated:

**Table: Amounts greater than listed require a transport license and manifest:**

Hazardous Waste	Amount
Solids	5 kg
Liquids	5 litres
Compressed Gases (container capacity)	5 litres
Waste Oil	210 litres
Waste Paint	210 litres
Waste Batteries	1,000 kg
PCB (liquid or solid)	Any quantity that contains greater than 500 g of PCB
